



AND WHENEAU the said Trustees: have been put in possession of the aforementioned funds of the Trust and an such they own, posses and manage the same and undertake to carry out the purpose of the Trust within the ambit and power authority vested in them by virtue of these presents.

NOW THIS INDEMFURE WITNESSETH THAT in pursuance of the aforcasid decision, conviction and in dedication of the funds hereby transferred in favour of the TRUST in implementation of the scheme arising cut of the desire and ambition of the Donor and in acceptance of the same by the TRUSTEES, the Donor hereby dedicates and constituted the TRUST and hereby declares that the TRUSTEES will run and organise the TRUST to achieve the following objects subject to the powers and provisions hereinafter declared and expressed for the purpose of establishing, managing and developing educational institutions mainly for the benefit of and for catering to the educational


needs of LIMQUISTIC AND RELIGIOUS MIMORITIES and generally to provide educational opportunities to all classes of students irrespective of caste, religion and creed.

- The name of the TRUST created under this DEED shall be "Abdul Hameed Memorial Educational Trust" also known as "A.H. Momorial Educational Trust".

 this deed there is no lummovable, properties belonging to the
 - 3. The objects of the Trust shall be as follows:
 - (a) To establish educational institutions for providing training in professional, bethnical, medical and general education from Mursery to Dogree clauses and also higher education;
 - (b) To establish and manage or to take over and manage one or more educational institutions particularly for the benefit of linguistic and religious minorities and

· in general for all classes of students irrespective of caste, religion and oreed;

- (c) To establish, manage and develop institutions to promote interests in Arty, Science, Li ratuture and Languages, from Nursery to College levels according to the needs of particularly linguistic and poligious minorities and Rennially of all classes.
- (d) To encourage and propagate adult literaty;
- (a) To Hoguire Properties, movable or immovable, by purchase, gift, donations etc. and to re-sell, lease or otherwise deal with the same in furtherance of the aims of the frust.
- (f) To collect funds for the proper conduct of the institutions under its management as donations, by way of contributions, aids, membership fees or any other source in any mannaer.
- (g) To organise public opinion in matters of educational importance and to do such other things as are incidental or conducive to the attainment of the objects of the Trust.




- (h) To edit, print, publish or/and distribute books, magasines, materials and pumphlers relating to educational subjects;
- (1) to institute scholarchips and treasnipo:
- (j) and, generally to do anything incidental or conducive to the above objects or any of them.
- 5. The Trustees shall bind themselves to manage and deal with the educational inelitutions run by the Trust in such a manner as may be most beneficial to the growth of the institutions and shall do every such thing as may be legally necessary for the maintenance and proper functioning of the said institutions.
- 6. For the purpose of administration of the effalls of the Trust and the institutions under the Trust, the Trustees together shall form themselves into a Board of Trustees.
- 7. Mr. Missar Ahmed, the DONOR and AUTHOR of the TRUST herein shall be the life-time MANAGING TRUSTEE of the BOARD OF TRUSTEES. He shall guide and supervise the destinies, proceedings and functioning of the TRUST and in the event of any dispute arising in respect of the interpretation

of the terms in the TRUST DEED of the objects of the TRUST, his decision shall be final. He shall also be the Chairman of all the Managing Committees constituted by the Hoard of Trustees to run and supervise the different activities of the Trust to carry out and implement any of the objects of the Truot.

- 8. When the Donor who shall be the Managing Trustee of the Trust for life time ceases to be the Managing Trustee by death or otherwise, any person nominated by him during his life time by specific testament, or any of his legal heirs shall become the DONOR TRUSTEE of the Trust.
- Scriptions, donations, gifts, grants from the Government or public bodies or individuals or organisations and shall have powers to acquire by way of purchase, gifts, grants, domine amalgamation taking over or otherwise, property of every description including movable and immovables for the use and the benefit of the Trust and calculated to promote the aims and objects of the Trust.
- 10. The Managing Trustees shall be empowered to raise loans or advances repayable with on without interest from Banks

or individuals at the time of need and also to acquire land to construct buildings for the adventional institutions of the fruct. The hundaring Trustees shall also have the powers to raise funds by organising benefit shows of any type, exhibitions, rates, lucky-dip etc.

- 11. The Trustees shall dedicate themselves to advancement of education and shall encourage and organise lectures, debates, discussions, symposia, book reviews and allied literary and cultural activities without any profit motive.
- 12. To translate the above objects into action, the Trustees shall endeavour to start now institutions or take over or amalgamate with the Trust other running educational institutions when the need is felt.
- 1). The Board of Trustees are empowered to form Managing Committees for the day-day administration and working of the educational institutions and the committees so formed whall meet in accordance with the Rules and Regulations laid down for that purpose.
- 14. The Hoard of Trusters whell have powers to trame Rules for the conduct of business and proceedings connected with the administration of the institutions and also lay down

the Rules and Regulations for conducting the outliness and proceedings of the managing Committee formed by them from time to time.


- 15. The Managing Trustee shall have powers whenever he thinks expedient to apply any part of the Trust Funds in acquiring or purchasing or taking on lease or otherwise any loud or building for the development of the Trust nativibles.
- ont apply any part of the funds for the publication of books compatible with the educational aims and curricular as well as the cultural values and importance.
- 17. So far as the investment is concerned, the funds of the Trust shall be invested in quordance with the provisions of Section 13(4)(d) read with Section 13(5) of the Income Tax Act 1961.
- 18. The Board of Trustees shall fixthe remuneration for the Bearing Trustees, Secretary and other persons associated with the activities of the Trust from out of the funds. However, payment of remuneration to them shall be reasonable and commensurate with the actual service rendered by each of them for the benefit of the Trust

- 19. The Managing Trustee shall have the powers to sanction all payments of the Trust from out of the funds of the Trust.
- 20. The Board of Trustees shall maintain or cause to be maintained operact accounts of the Income and Expenditure of the Trust.
- 21. The Managing Trustee shall have powers to appoint Olorko, Manager, Teachers and other staff for different Departments of the educational institutions under the Trust and fix their remuneration and frame service rules and further have powers to dispense with the services of any employee/s if his/her services are not desirable or required, with due notice wherever necessary.
- 22. Notwithstanding anything contained in this Deed the
 Board of Trustees shall have powers to modify, add,
 delete, amend any of the clause/clauses of the document
 or incorporate new provisions in this document consistent
 with the objects and purpose of the Trust provided at
 least three-fourth of the Trustees agree to the same.
- 23. Three-fourth of the total number of members shall form the quorum for all purposes including the amendment to this Deed.

- 24. The Managing Trustee shall have powers to negotiate, conclude and effectuate such agreements with the State and Central Governments or any other local authorities or bodics of Company or Companies or inalylduals for the purpose of obtaining impensial or technical air commandation any rights, privileges or concessions, if any. In any form so they deem fit on such terms and conditions as may appear fit to them or the furtherance of the objects of the frust.
- 25. The Board of Trustees and the Trustees individually and to be generally governed by the provisions of the Indian Trust Act.
- 26. The Ecord of Trustees shall meet at least once in every three months to take stock of the progress achieved and to transact other business pertaining to the activities of the Trust.
- 27. The Board of Trustees shall appoint a Chartered Accountant or a Certified Auditor and get the accounts audited yearly and appoint an Advocate as and when occasion arises and they shall be paid reasonable remunerations for their advoces.



- 28. The Managing Trustee shall have the power to remove any of the Trustees if any of the acts of such TRUSTER/2 is dewimental in any manner to the TRUST or to the interest of educational institutions under the TRUST.
- 29. The Managing Trustee, shall have the power to nominate any new of additional Trustees on conditions and terms to be indicated by the Managing Trustee himself.
- The Manual regularity dependence shall open accounts/Account in any Bank/Banks in the name of the Trust or in the names of educational institutions under the Trust and he shall operate the said Account/Accounts himself or he may also cultivise any other Trustee in writing to operate such account/s
- 31. Upon dissolution or winding up of the Trust, if ther shall remain after the settlement of all its dobts and liabilities, any property whatsoever, the same shall not be paid to or distributed among the Trustecs or any one also but shall be given to some other Trust on Society or Charitable Institution or Association or institutions whose objects are similar to those of this Trust.
